**Online Registration of Application and Online Payment of Fee: From 09.12.2022 To 29.12.2022**

State Bank of India invites On-line application from Indian citizen for appointment in the following Specialist Cadre Officer posts on regular basis. Candidates are requested to apply On-line through the link given in Bank's website <https://bank.sbi/web/careers> or <https://www.sbi.co.in/web/careers>

1. The process of Registration is complete only when fee is deposited with the Bank through Online mode on or before the last date for payment of fee.
2. Before applying, candidates are requested to ensure that they fulfill the eligibility criteria for the post as on the date of eligibility.
3. Candidates are required to upload all required documents (brief resume, ID proof, age proof, educational qualification, experience etc.) failing which their candidature will not be considered for shortlisting / interview.
4. Short listing will be provisional without verification of documents. Candidature will be subject to verification of all details/ documents with the original when a candidate reports for interview (if called).
5. In case a candidate is called for interview and is found not satisfying the eligibility criteria (Age, Educational Qualification and Experience etc.) he/ she will neither be allowed to appear for the interview nor be entitled for reimbursement of any travelling expenses.
6. Candidates are advised to check Bank's website <https://bank.sbi/careers> regularly for details and updates (including the list of shortlisted / qualified candidates). The Call letter / advice, where required, will be sent by e-mail only (No hard copy will be sent)
7. In case more than one candidate scores same marks at cut-off marks in the final merit list (common marks at cut-off point), such candidates will be ranked in the merit according to their age in descending order.

9. All revision / corrigenda will be hosted only on the Bank's above mentioned websites.

#### NOTE:

1. Candidate belonging to OBC category but coming in the 'creamy layer' are not entitled to OBC reservation and age relaxation. They should indicate their category as 'GENERAL' or GENERAL (PwBD) as applicable.
2. The number of vacancies including reserved vacancies mentioned above are provisional and may vary according to the actual requirement of the Bank.

10. In cases where experience in a specific field is required, the relevant experience certificate must contain specifically that the candidate had experience in that specific field.
11. VI and HI category candidates will not be suitable in these positions, as it will require travel, interaction and giving presentation at various levels etc.
12. The Basic Educational qualification prescribed for the post is minimum. Candidate must possess the qualification and relevant full-time experience as on specified dates.

<p><b>(E) Selection Procedure:</b> The selection will be based on shortlisting-cum-interaction.  <b>Shortlisting:</b> The Shortlisting Committee constituted by the Bank will decide the shortlisting parameters and thereafter, adequate number of candidates, as decided by the Bank will be shortlisted (subject to availability) and called for interview. The decision of the Bank to call the candidates for the interview shall be final. No correspondence will be entertained in this regard.  <b>Interview:</b> Interview will carry 100 marks. The qualifying marks in interview will be decided by the Bank. No correspondence will be entertained in this regard. Mere fulfilling minimum qualification and experience will not vest any right in candidate for being called for interview.  <b>Merit List:</b> Merit list for selection will be prepared in descending order on the basis of scores obtained in interview only. In case more than one candidate score the cut-off marks (common marks at cut-off point), such candidates will be ranked according to their age in descending order, in the merit.</p>	
<p><b>(F) Call Letter for Interview:</b> Intimation/ call letter for interview will be sent by email and will be uploaded on Bank's website. NO HARD COPY WILL BE SENT.</p>	
<p><b>(G) How to Apply:</b> Candidates should have valid email ID which should be kept active till the declaration of result. It will help him/her in getting call letter/ Interview advices etc. by email.</p>	
<p><b>GUIDELINES FOR FILLING ONLINE APPLICATION:</b>  i. Candidates will be required to register themselves online through the link available on SBI website <a href="https://bank.sbi/web/careers">https://bank.sbi/web/careers</a> OR <a href="https://www.sbi.co.in/web/careers">https://www.sbi.co.in/web/careers</a> and pay the application fee using Internet Banking/ Debit Card/ Credit Card etc.  ii. Candidates should first scan their latest photograph and signature. Online application will not be registered unless candidate uploads his/her photo and signature as specified on the online registration page (under 'How to Apply').  iii. Candidates should fill the application carefully. Once application is filled-in completely, candidate should submit the same. In the event of candidate not being able to fill the application in one go, he can save the information already entered. When the information/ application is saved, a provisional registration number and password is generated by the system and displayed on the screen. <b>Candidate should note down the registration number and password.</b> They can re-open the saved application using registration number and password and edit the particulars, if needed. This facility of editing the saved information will be available for three times only. Once the application is filled completely, candidate should submit the same and proceed for online payment of fee.  iv. <p><b>GUIDELINES FOR PAYMENT OF FEES:</b>  i. Fee payment will have to be made online through payment gateway available thereat.  iii. After ensuring correctness of the particulars in the application form, candidates are required to pay the fees through payment gateway integrated with the application. <b>No change/ edit in the application will be allowed thereafter.</b>  iv. Transaction charges for online payment, if any, will be borne by the candidates.  v. Size of file should be between 20 kb-50 kb and Dimensions 200 x 230 pixels  iii. Make sure that the picture is in colour, taken against a light-coloured, preferably white, background.  iv. Look straight at the camera with a relaxed face  v. If the picture is taken on a sunny day, have the sun behind you, or place yourself in the shade, so that you are not squinting and there are no harsh shadows  vi. If you have to use flash, ensure there's no "red-eye"  vii. If you wear glasses make sure that there are no reflections and your eyes can be clearly seen.  viii. Caps, hats and dark glasses are not acceptable. Religious headwear is allowed but it must not cover your face.  ix. Ensure that the size of the scanned image is not more than 50kb. All Documents must be in PDF format.  ii. Page size of the document to be A4.</p>	<p>iii. Size of the file should not be exceeding 500 KB.  iv.
